Dear Parent/Guardian:

Thank you for your interest in the Independent Study Physical Education (I.S.P.E.) program. We support and appreciate after-school activities, and we encourage students to participate in them. For the most part, however, these outside sports do not take the place of the regular physical education class which offers an introduction to diverse sporting activities in the context of a cooperative classroom environment. Students are encouraged to participate in the on-campus physical education program, especially at the 7-10 grade levels.

While our primary recommendation is that all students participate in the district physical education program, we do offer an independent study physical education program for (1) exceptionally gifted, state or regionally ranked athletes, (2) students wishing to take an advanced level in a course we are not currently offering, (3) students who have restricted schedules such as AVID, (4) students with medical conditions, or (5) students who have fulfilled their high school graduation P.E. requirement.

An independent study course requires personal accountability and maturity. Students in I.S.P.E. will be responsible for fulfilling the requirements of the I.S.P.E. contract, which include completion of all paperwork, filing of all workout logs, and submission of all reports. Details of the requirements are contained in this packet. Individuals are selected based upon their ability to handle the individual responsibility.

Please understand that due to the independent nature of the program, a large part of the grade (pass/fail) that your son/daughter receives will be based upon his/her accomplishment of the agreed objectives, and his/her communicating this information to the I.S.P.E. Coordinator in a timely fashion.

***Based on the advice of legal counsel, the SDUHSD now requires all I.S.P.E. instructors/coaches to provide insurance verification and the hold harmless agreement provided in this packet.***

- (5) Coach/instructor's Hold Harmless Agreement and Certificate of Insurance
- (6) Parent Release of Liability form
- (7) A portfolio is required for all students who wish to qualify using criteria 1 or 2 (see reverse side of sheet)

The following is to be included in the portfolio:

- Items (1) through (6)
- Official competition records, results, ranking (regional, state or national level required)
- Calendar of competitive events
- Copy of organization membership card
- Other evidence of advanced ranking

**CRITERIA**

*To qualify for I.S.P.E. one of the following criteria must apply:*

**Criteria One:** *To provide exceptionally gifted athletes who are competing at a regional, state or national competition or performance with in-depth opportunities. Portfolio documenting competition level to be included.*

**Criteria Two:** *To participate in an advanced study of a course adopted by the San Dieguito Union High School District which is not available through the district Physical Education or extra-curricular program.*

**Criteria Three:** *To provide an alternative for students who are in special academic support programs (i.e. AVID) during the regular school day which preclude taking a regularly scheduled P.E. class.*

**Criteria Four:** *To provide an alternative for students who are medically prohibited from participating in regular P.E. classes, and who are under a physician's supervision, and who will follow prescribed physical activities.*

**Criteria Five:** *Has fulfilled high school physical education requirement and elects to take an extra elective in grades 11 and 12.*

**Guidelines**

1. Student participation on district or community athletic team sports such as baseball, basketball, football, lacrosse, soccer, softball, volleyball will not be granted Independent Study P.E. credit. Per CIF 600.2.A
2. The I.S.P.E. courses must develop proficiency, knowledge, and skills that cannot be achieved within the in-school physical education program.
3. The direct instruction requirement must be equal to or exceed the hourly requirement of the district P.E. program as follows: Middle Schools/LCC/TPHS – 400 minutes every 2 weeks; CCA/SDA – 400 minutes every single week.)
4. Special needs students on I.S.P.E. must follow course requirements.
5. The parent will be required to sign a District Liability Waiver Form which holds the District harmless from any liability or claims as a result of the I.S.P.E. program.
6. All I.S.P.E. instructors/coaches are to provide insurance verification and the hold harmless agreement provided in this packet.
7. Second semester grade 7 and 9 I.S.P.E. students must contact a school P.E. teacher to find out when he/she can participate in the state mandated physical fitness testing. It is the student's responsibility to find out when the testing will occur, to schedule the testing with the instructor, and to attend the regular P.E. classes during the testing period.
8. Students in grades 11 and 12 who have completed their two years of P.E. credit for graduation may take I.S.P.E. as an elective if they meet all of the criteria for participating in I.S.P.E.
9. The parent/guardian agrees to undertake all transportation of the student to and from I.S.P.E. The District will not provide transportation.
10. The I.S.P.E. course must be part of the student's regular bell schedule. I.S.P.E. may NOT be an additional period. For example, if the school has a six period day, I.S.P.E. must be one of six classes, NOT a seventh class.
11. **While the schools will establish certain requirements in implementing this policy, the San Dieguito Union High School District and its schools are not responsible for the quality or conditions of instruction conducted off school premises in the I.S.P.E. program.**

Independent Study Physical Education (I.S.P.E.)**

**Course Requirements**

1. The participation requirements must equal or exceed the hourly requirement of the district P.E. program; Middle Schools/LCC/TPHS: 400 minutes of direct instruction every two weeks; CCA/SDA: 400 minutes of direct instruction every single week.
2. I.S.P.E. logs must be submitted indicating days and hours of instruction. Logs must be signed by your instructor and parent. Logs are available at the attendance office or from your I.S.P.E. coordinator.
2. On the Wednesday of the last week of the quarter/term, a one-page paper is due from the student indicating his/her self-evaluation of progress toward stated goals. In addition, a one-half page statement personally written and signed by the I.S.P.E. coach/instructor is due which indicates that satisfactory progress is being made toward the goals.
3. On the Wednesday of the last week of the semester, a two-page paper is due which must include:
  - (a) the student's evaluation of his/her success in attaining the stated goals and objectives, answers to the questions on the report form relative to the student's sport/activity, and a statement indicating future goals if the student intends to continue the same activity for an additional semester, and
  - (b) a one-page statement personally written and signed by the I.S.P.E. coach/instructor evaluating the student's semester participation and progress.
4. All second semester grade 7 and 9 I.S.P.E. students must make arrangements with the I.S.P.E. coordinator to take the state mandated California Physical Fitness test. The results of such tests must be recorded, signed and dated by the physical education instructor administering the test. This information must be turned in during the second semester.

**Dropping an Independent Study P.E. Course**

1. A student may drop a class anytime during the first four weeks of a semester (two weeks for the 4 X 4 schedule) without a grading penalty on the student transcript, if approved by the parent/guardian and school counselor.
2. After the fourth week (second week for the 4 X 4 schedule) of the semester a student who drops a class will receive a withdraw/no credit on the student transcript.
3. No class may be dropped within 30 school days (15 days for the 4 X 4 schedule) of the final marking period, nor may any class be added for transfer units within 30 school days (15 days for the 4 X 4 schedule) of the final marking period.

**Middle School Requirements**

Early second semester, all seventh graders are required to take the state's mandated Physical Fitness Test. Included in the test are the following: the mile run, sit and reach or shoulder stretch, curl-ups, push-ups, trunk lift, and height & weight testing. It is highly recommended that your child practice the mile run, curl-ups, push-ups and flexibility in preparation for these tests. Please include your child's timed mile run with each ISPE log. For a student to be accepted into the I.S.P.E. program they must be an "exceptionally" gifted athlete. The following standards, representing results within the 85<sup>th</sup> percentile in our nation, should be met by I.S.P.E. students:
